# 2 PROPOSAL OF HUNGARIAN BANDY FEDERATION REGARDING YOUTH TOURNAMENTS

## Proposal in short:

B-nations should be allowed to fully compete with teams that are up to 2 years older than the age group for the tournament.

# Addition by HBF/Kristian Marosi:

The meaning of the proposal was basically any nation that is not part of the big 4 (Sweden, Finland, Norway, and Russia), so smaller nations can create more teams. I would say that if a

nation continuously can take part in maybe 75% of the tournaments, are no longer a "B-nation" and therefor the regular conditions apply for them. Maybe have it more like that, and that would create less misunderstandings I believe and remove the B-nations wording.

After a long discussion, the proposal is NOT approved as is written.

However, FIB TC does approve, for this season only, the proposal with extra conditions. We will evaluate afterwards.

The following conditions apply for exempted teams:

- takes part as other teams
- will be ranked together with the other participating teams
- can not win a medal. So, for example, can not play the gold- or bronze-medal match
- the results of the teams who play against an exempted team will not count in case the points and/or goal score/difference is in any way deciding for them. Just to not be influenced by a team that (as example) scores 8-1 to the exempted team, compared to a team that scores 4-4.

Evaluate after tournaments/season: to continue yes/no or for one more or even more years.

# 3 PARTICIPATIONS OF INDIA IN WCS Y17 AND WC Y19 (AND WCS Y19)

Indian Bandy Federation applied for participation in the first two mentioned tournaments and maybe they will also for the third.

FIB SG Attila Adamfi asks FIB TC for their opinion on this matter.

# **Kjell Anderstedt** has found out:

- India have never played bandy for 11 players on a full sized bandy pitch. Only rink bandy on a hockey rink. They had their national championship in Rink bandy in the beginning of October this year.
- When it comes to economy they have the funds to finance participating in a FIB international tournament.

## Some remarks made in the meeting:

- We have never seen a team from India played 11-a-side bandy, we expect it will be very tough for them, especially in WCS Youth where only the "group A" teams participate.
- Would love to have them in the bandy family.
- Regarding previous experiences with Somalia, participation in these tournaments might not be good for bandy in general, and also not for bandy in India.
- Invite to WCS Y17 or WC Y19 and let them play against local teams, and get theory/education?

TC must have rules/requirements when a team can start at a WCS Youth and/or Senior. Bigger nations should take responsibility for small nations with trainingcamps, tournaments etc.

Decision: **Stein Pedersen** and **Ravi Sunder** will contact Indian Bandy Federation regarding this matter.

  - National transfers were found as a way to participate not the meaning. Do we need windows for national transfers?
  - o Exemptions must be handled in a clearer way.
  - Conditions for WC must be very strict.
  - o Supervisor from TC should be in WC too.
- Men: 3-Nation's tournament? Will it be organized? Pär Gustafsson can answer??
- Women: 3/4/5-Nation's tournament for women? Will it be organized? USA and Netherlands are interested.
