

## MINUTES FROM THE FIB COMPETITION COMMITTEE (CC) MEETING

### 1. THE RE-ORGANIZATION OF FIB COMMITTEES

Attila Adamfi gave the background to the reorganization of the committees, primarily the changed responsibilities for the new Competition Committee and Technical Committee. The ambition is to streamline the tasks between the committees and to ensure that its members have their own special knowledge in their respective areas. CC will focus on Tournaments, Timetables etc. and TC will focus on technical responsibility such as Conditions, Equipment rules, etc. The representation from national associations is in CC. The CC and the TC shall have a good collaboration. That is secured as both Chairs participates in each others meetings. ### 2. 5 WORLD CHAMPIONSHIPS IN UPPSALA DURING 2 WEEKS IN MARCH

Kjell Anderstedt and Daniel Andersson gave information on the procedure that led to this unique 5 tournament solution in one arena for two weeks. It is a collaboration between FIB, SBF, Uppsala BoIS, IFK Uppsala and Uppsala Municipality.

## 3. COST ADJUSTMENTS NECESSARY FOR WCS MEN AND WOMEN GROUP B

IFK Uppsala and FIB are looking at the costs and possible adjustments för WCS Men and Women B-group to get a balanced budget. Adjustments discussed are fewer single rooms used, a closing without banquet and coordinated transport for the teams. Decision later.

### 4. EVENT PLANNING PROCESS 2026-2027

The planning process has begun when FIB sent an invitation to all Member Associations to send in their interest in hosting tournaments the season 2026-2027. Next CC-meeting will discuss a proposal for hosting tournaments to EC. The EC decision will be made at the latest of December 2025.

# 5. PROPOSAL FROM SBF REGARDING WCS WOMEN 17, MEN 17 AND MEN 19 SEASON 2026-2027

Daniel Andersson proposed that those 3 youth tournaments should be held in Uppsala also for the season 2026-2027 to give the organizer good possibilities to host the tournaments a second year. CC decided unanimously according to the proposal.

CC will have a broader discussion ahead of coming years which tournaments can be held in the same place for 2-3 years and which tournaments should be possible to host for different national member associations.

### 6. REVIEW OF THE COSTS FOR REFEREES IN INTERNATIONAL TOURNAMENTS

During last season's evaluation of FIB youth tournaments, it became clear that the single biggest financial problem for organizers in balancing their budgets is referee costs. Pär Billsmon was given a mandate to review the various costs for referees during international tournaments. The task had previously been assigned to the former RRC, but the change in chairmanship has delayed the review.

## 7. ANNUAL SPRING MEETING WITH THE REFEREES COMMITTEE

Arne Anderstedt told that previously, there was a routine with a meeting between TC and RC to discuss various common issues such as certain rule issues and equipment questions. The idea of resuming will be passed on to TC.
